OVER 400 CHILDREN PARTICIPATED IN WEEKDAY, WEEKEND AND SCHOOL VACATION PROGRAMS, WHILE OVER 7,000 SCHOOL AGE STUDENTS WERE VISITED EITHER IN THEIR SCHOOLS OR OUT ON FIELD TRIPS TO THE VAN VLECK FARM & NATURE SANCTUARY.
